Fee Schedule


- 48 Hour Name Check: \$50 (\$10 extra for original/certified)
- Ink & Roll Fingerprinting: \$40 1st set (\$30 each additional set)
- Digital Fingerprinting: \$50 + \$25 RCMP fee
- Ink Digitization (applicants outside Canada): \$90 + \$25 RCMP fee

NOTE: GST Extra. **\$25 RCMP fee waived** for applications involving Citizenship and Immigration Canada (CIC), Federal Employment and Privacy Requests.

Identification Required During Appointment

Bring TWO Pieces of Identification. One **must** include a photograph.

- **Photographic ID:** Provincial Drivers' License or Identification Card, Passport, Canadian Citizenship Card, Permanent Resident Card (ONLY ID with an expired date that is acceptable), Firearms License, Refugee Protection Claimant Document—Certified, Treaty Status Card, Nexus Card, Record of Landing and Military Identification Card.
- **Government ID (no photo):** Alberta Health Care Card, Birth Certificate, Certificate of Live Birth, Marriage Certificate, Immigration Papers (includes VALID document issued by CIC with applicant information), Alberta Wildlife Identification Number (WIN) card.
- **Other Documentation (if applicable):** Letter from requesting party.
- **Digital Fingerprinting Requests for Canadian Citizenship:** Letter from Citizenship and Immigration Canada requesting fingerprinting.
