### Steps for Getting an RCMP Certified Criminal Record Background Check in Canada For individuals residing outside Canada

- #1. CARDSCAN REQUIRED INFORMATION FORM and CONSENT FOR CERTIFIED CRIMINAL RECORD CHECK  
☐ You must fill in the CardScan form AND read/sign/date the Consent for Certified Criminal Record Checks form.
- #2. THIRD PARTY CONSENT FORM  
☐ ONLY complete this form if you want the RCMP to mail the results directly to a Third Party.
  - Insert the name of the person OR name of the company you want the results mailed to.
  - Insert the Third Party's mailing address.
  - Sign and date this form.
  - **CAUTION:** The RCMP will ONLY mail the results by ordinary mail to you or your designated Third Party.☐ SELECT OPTION 2 ONLY if you want us to receive the results by ordinary mail from the RCMP and to then courier the results to you or a Third Party outside Canada. Courier charges are extra. **If you select this option, we will automatically email the results to you before sending them to you by courier.**
- #3. PHOTOGRAPH AND IDENTIFICATION  
☐ Provide us with a recent photograph of you (headshot), approximately 2 inches x 2 inches (a little bigger is also acceptable). This photograph must match your Identification. It should have a light background. See sample attached. It does not have to be as perfect as a passport photograph but it should be similar in quality.  
☐ Provide us with a photocopy of two pieces of NOTARIZED identification (see Identification Checklist).
- #4. ATTEND YOUR **LOCAL POLICE OR EMBASSY** FOR FINGERPRINTING  
☐ You must go to your **local police or embassy** for fingerprinting. ONLY if the local police or embassy will NOT provide you with fingerprints, then you may go to a **Fingerprint Agency** that has been authorized by the police to provide fingerprinting services. ONLY if the first 2 options fail, you may go to a **Notary Public** for fingerprinting. SEE FINGERPRINTING TIPS.  
☐ Have the fingerprinter take your full set of fingerprints on the FINGERPRINT FORM enclosed OR you may use the standard form provided by your police or embassy.  
NOTE: they must print or stamp their name and agency on the fingerprint form AND you BOTH must sign it.  
☐ Your full name must appear on this form AND you must sign AND date it.  
NOTE: the authenticity of the fingerprinter and fingerprint company WILL be verified.
- #5. INVOICE  
☐ Complete this form.  
☐ Print proof of payment if paid by email or paypal.
- #6. OPTIONAL PRE-APPROVAL OF PACKAGE  
☐ Scan and email the entire package for advanced approval to:

- #7. MAIL or COURIER THE FOLLOWING TO US:
  - ☐ Completed Cardscan Form AND Consent for Certified Criminal Record Check;
  - ☐ Completed Third Party Release, if you want the results sent directly to a Third Party by the RCMP;
  - ☐ Full set of fingerprints signed by you and the fingerprint officer;
  - ☐ Color Photograph;
  - ☐ Photocopy of 2 pieces of NOTARIZED identification (see Identification Checklist for requirements); and
  - ☐ Invoice (filled in as per above) including proof of payment if paying by email transfer or paypal.
- #8. Once we receive your package, we will post payment (if paying by credit card), digitize your fingerprints and submit your fingerprints electronically to the RCMP. We will send you email confirmation when this has been completed, including instructions on how to follow up with the status of your RCMP report if you have not received the results within 6 weeks.

## SHIPPING STANDARDS

### #1. RCMP Processing Times

RCMP takes an average of 3 to 7 days to process your request (provided you have no criminal record in Canada AND your fingerprints are not too difficult to read). If you have a criminal record OR hard to read fingerprints, it could take over 120 days for the RCMP to process your request. You then need to add on the time it takes for the results to be delivered to you.

### #2. Canada Post Ordinary Mail

The RCMP will ONLY mail the results via ordinary mail. The RCMP will NOT courier the results. The following are average times for RCMP to mail the results to your specified address.

- (a) Results mailed from RCMP Ottawa to a Canadian Address: 3 to 5 business days

NOTE: Canada Post advises it could take upwards of 9 days if you live in a remote area.

- (b) Results mailed from RCMP Ottawa to a U.S.A. or International Address

The estimated delivery standards for Letter-post (U.S.A. and International) are:

<b>U.S.A.</b>	4 to 6 business days
<b>International</b>	4 to 7 business days

NOTE: It could take longer if you are in a remote area. Canada Post does not guarantee these delivery standards. Postal delivery times within your country by your local delivery service is in addition to above.

**CAUTION: please check post office in your country for delivery standards . Canada Post delivers to your country and post office in your country delivers to you.**

## IDENTIFICATION REQUIRED

Applicants must provide a **PHOTOCOPY** of 2 pieces of **NOTARIZED** valid government identification (Federal, Provincial or Municipal) of which:

1. Both have your name and date of birth;
2. At least ONE must have signature;
3. Provide copy of front and back of cards; and
4. At least ONE has a photograph.

### CANADIAN IDENTIFICATION (MUST BE VALID / NOT EXPIRED)

- **Photographic Identification:**
  - Provincial Drivers' License or Identification Card
  - Canadian Passport (entire signature page & photographic page)
  - Canadian Citizenship Card
  - Permanent Resident Card (ONLY ID with an expired date that is acceptable)
  - Firearms License
  - Refugee Protection Claimant Document—Certified
  - Treaty Status Card
  - Nexus Card
  - Military Identification Card
- **Government Identification (no photo):**
  - Alberta Health Care Card
  - Alberta Wildlife Identification Number (WIN) card.
  - Birth Certificate, Certificate of Live Birth
  - Marriage Certificate
  - Immigration Papers (includes VALID document issued by CIC with applicant information)
  - Record of Landing
  - Social Insurance Card

### NON-CANADIAN GOVERNMENT IDENTIFICATION (MUST BE VALID / NOT EXPIRED)

- Foreign Driver's License
- Foreign Passport
- Government Issued Birth Certificate
- United States Social Security Card
- Student Identity Card from a foreign educational institute
